

MSPA YOUTH FLOCK GRANT

DESCRIPTION: This is a one-time \$2,500 grant administered through MSPA and funded by donations from Diane Allmen, Claudia Chapman, and the Northern Michigan Lamb and Wool Festival.

PURPOSE: The purpose of this grant is to provide two Michigan youths \$1,250 in funds with which to purchase a starter flock of sheep or to purchase sheep to add to and improve an existing flock owned by the youth.

RULES AND REQUIREMENTS:

1. Youth must be ages 9 years through 18 years to apply. Age is determined as of January 1, 2022.
2. Youth or their family must be a member of MSPA or join MSPA to apply.
3. Youth must be a Michigan resident to apply.
4. Funds must be used to purchase live animals. If there are residual funds after the purchase of animals they may be put toward feed and/or equipment.
5. Animals are to be purchased by the youth, in the name of the youth, for their own personal starter flock or established youth flock. Animals are not to be purchased for family flocks. Animals may reside with the family flock.
6. Animals are to be purchased for the purpose of starting or improving a breeding flock, not for immediate resale. Purchased animals are not to be sold, transferred, or given away for at least 12 months after the time of purchase.
7. Sheep purchased may be of any breed or type- purebred, commercial, club lamb, fiber flock, hairsheep, etc.
8. MSPA Youth Flock Grant application and all supporting materials must be received by email on or before November 1, 2022.
9. Applications will be reviewed by the MSPA Youth Flock Grant Committee and winners will be determined by November 15, 2022. The winners will be contacted by December 1, 2022.
10. The grant winners will be invited to the 2023 Michigan Shepherd's Weekend banquet on Saturday, January 7th and will be recognized during the awards program.

11. The grant winners will not receive funds until letters of thanks to the sponsors are submitted to the MSPA Youth Flock Grant Committee. The Committee will ensure the letters are sent to the sponsors.
12. The grant winners will be required to do a presentation about the grant, their new animals and flock at the 2024 Michigan Shepherd's Weekend Friday night Young Producers event.
13. In the event that two winners are not chosen, the remaining funds will be offered as a Youth Flock Grant the following year.
